("THE RELEASEES").

In consideration for allowing me (or my minor child) to ride our own horses in the indoor arena and on behalf of myself, my child or our personal representatives, heirs, next-of-kin, spouses and assigns, I HEREBY:

- Acknowledge that insurance for animals, personal property and individual is the complete and full responsibility of the Rider.
- Acknowledge that horseback riding is an inherently dangerous activity and involves risks that may cause serious injury and in some cases death, because of the unpredictable nature and irrational behavior of horses, regardless of their training and past performance.
- 3. Voluntarily assume the risk and danger of injury or death inherent in the use of the indoor riding arena provided for your use by QuarterCircle9K Boarding & Arena, hereinafter referred to as the Arena.
- 4. RELEASE DISCHARGE AND PROMISE NOT TO SUE the Arena, doing business under its own name or any other name and/or any of its owners, officers, employees, directors and agents (hereinafter the "Releasees"), for any loss, liability, damages, or cost whatsoever arising out of or related to any loss, damage, or injury (including death) to my person or property.
- 5. Release the Releasees from any claim that such Releasees are or may be negligent in connection with my riding experience including but not limited to arena layout, arena access, arena lighting or parking facilities.
- 6. INDEMNIFY, SAVE AND HOLD HARMLESS the Arena, its employees and agents from and against any loss, liability, damage or cost they may incur arising out of or in any way connected with either my use of the arena or any acts or omissions of other employees or agents.
- Acknowledge under Colorado law, an equine professional is not liable for an injury to or the death of a
  participant in equine activities resulting from the inherent risks of equine activities, pursuant to Section
  13-21-119, Colorado Revised Statutes. (RIDE AT YOUR OWN RISK)
- 8. Rider agrees, in the event medical assistance is needed, participant listed above will be responsible for all medical payments.

I have read this entire Release of Liability Document. I understand it is a promise not to sue and to release
the Arena, Releasees and agents from all claims. I have made a free and deliberate choice to sign this
Release and Waiver as a condition to Releasees allowing me or my child to ride or handle a horse.
